AWB / OBL – Client's name must be the same as on the passport. C/O FIDI Partner.
<b>Automobiles</b>	<ul style="list-style-type: none"> <li>Used Automobiles prohibited</li> <li>New automobiles may be imported and subject to a substantial government tax.</li> </ul>	The original purchase invoice and insurance certificate are required.	Used automobiles cannot be imported into Macau. New vehicles with both left-hand and right-hand drive may be imported, but must be handled by a professional automobile importer.
<b>Wine &amp; Liquor Tax</b>	<p>A detailed wine list with quantity, brand name, type, volume, alcohol %, price per bottle and total value is required.</p> <p>You need to take photos for each bottle one by one, it must show the wine brand name, type, volume, alcohol %, per bottle.</p>	<p>Alcohol and Wine:</p> <ul style="list-style-type: none"> <li>Liquor with an alcoholic strength of more than 30% by volume measured at a temperature of 20C – 100% duty.</li> <li>Liquor other than wine with an alcoholic strength of not more than 30% by volume measured at a temperature of 20C – 0% duty.</li> <li>Wine – 0% duty.</li> </ul> <p>* If insufficient information available, MOP 160 per liter may be assessed.</p> <p>Import of any type of alcohol even if duty free may cause a customs examination with additional costs and delays.</p>	<p>For the wine shipment, it must be applied by the Macau Resident (must have the Macau I.D.).</p> <p>The Import license: around 7-10 working days for application request (the import license is valid for 3 months).</p> <p>Please apply for the import license approved before the shipment come to Macau.</p> <p>Macau customs will open the boxes and <b>take the photos one by one</b>, they need to make sure each bottle wine list with quantity, brand name, type, volume, alcohol %, per bottle is correct.</p> <p>An incoming passenger is allowed to bring in without declaration the followings:</p> <ul style="list-style-type: none"> <li>1 litre of grape wine or beverages of alcoholic strength by alcohol volume not exceeding 30%.</li> <li>-1 litre of beverages of alcoholic strength by volume exceeding 30% vol.</li> </ul>

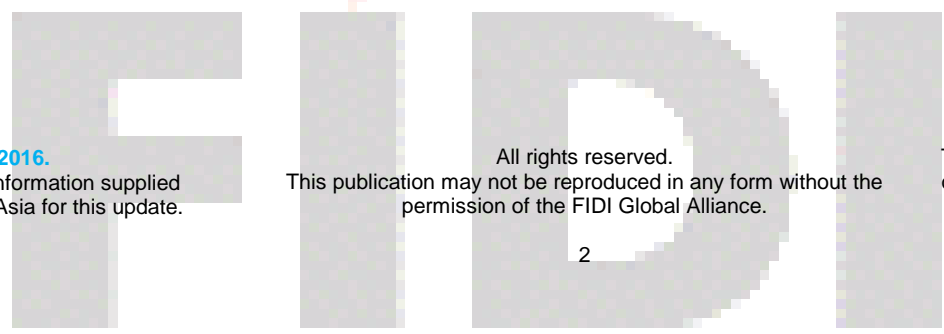

<b>Firearms and Dangerous Goods</b>	Firearm Certificate from Police prior to arrival.	Items require a valid firearm certificate issued to the owner by the Police Authorities controlling the area in which transferee intends to live.	Sending guns and ammunition to Macau is highly discouraged. Explosives and fireworks prohibited.
<b>Food</b>	- N/A, please see remarks.	N/A.	Non-perishable food items for personal use may be imported in small amounts in cans or other durable packaging.
<b>Pets</b>	An import permit is required by the Animal Health Department.	Import license required	Quarantine may be required depending on the type of animal and the country of origin. Check with your FIDI Partner prior to shipping.
<b>Drugs and medicine</b>	N/A, please see remarks.		Items are not allowed to be imported in household goods shipments. The local authorities recommend every day medicines be hand carried.
<b>Personal computers and printers</b>	N/A, please see remarks.		Normal home PC & laptop computers do not required an import permit; but all software must be original under the copyright law.
