<p><b>Russian citizens</b></p>	<ul style="list-style-type: none"> <li>▪ Copy of Passport, 1st page (internal and international passport).</li> <li>▪ Copy of visa from/to destination country.</li> <li>▪ Copy of registration in Russian Federation</li> <li>▪ Inventory.</li> <li>▪ Power of attorney legalised by Russian notary.</li> <li>▪ Customs Declaration filled out upon entry to the Russian Federation (only for returning Russians importing their goods on a preferential basis).</li> <li>▪ INN (Russian individual tax payer number).</li> </ul>	<ul style="list-style-type: none"> <li>▪ Imported goods are subject to customs duties in the amount of 30% of their value, but not less than 4 EUR/1 kg.</li> <li>▪ However, all agents and all involved in the organization of cargo import to Russia should be aware that the weight of the shipment must be rational and consistent with value. Before packing, it is important to consult with an agent in the country of destination regarding the weight of the shipment and its value.</li> <li>▪ The consignee of the shipment can make payment of import duties customs either from their bank account, in cash in the bank office or through online banking.</li> <li>▪ Any Russian citizen can import personal effects on a duty-free basis if the goods are worth up to five thousand Euro and the consignee has a letter from the Consulate of the Russian Federation confirming his/her registration in the Russian Consulate in the country of stay for more than 1 year.</li> <li>▪ People, entitled to duty-free import:               <ul style="list-style-type: none"> <li>▪ Employees of Embassies and Consulates and members of their families (once per calendar year during the period of stay abroad)**</li> <li>▪ People sent to work in a foreign country by the state bodies of the Russian</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ Objects of art must have a certification by Ministry of Culture.</li> <li>▪ Sometimes, customs requires presence of the Customer during customs clearance process.</li> <li>▪ Drafts of the letter to the Customs, PoA will be provided by the agent in Russia.</li> <li>▪ Letter from the Russian Consulate (original).</li> <li>▪ T6 Declaration has to be filled out by the shipper at the airport of arrival in Russia.</li> <li>▪ Customs broker can cover duties amount instead of the customer in case they have an agreement with each other.</li> </ul>

It can be extended for the period of validity of the new card.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Sometimes customs requires the presence of the owner of the vehicle or the representative of the Embassy during customs clearance.</li> <li>▪ Templates of the required documents will be provided by the agent in Russia.</li> <li>▪ By their personal request, the owners of the imported shipment can conduct customs clearance on 'general' grounds.</li> </ul>
<b>Vehicles belonging to other individuals</b>	<ul style="list-style-type: none"> <li>▪ Copy of the 1st page of passport.</li> <li>▪ Copy of visa (for non-residents).</li> <li>▪ Copy of registration in the Russian Federation.</li> <li>▪ Power of Attorney legalized by a Russian notary.</li> <li>▪ A document confirming the right of ownership of the vehicle.</li> </ul>	<ul style="list-style-type: none"> <li>▪ The duties shall be paid if the vehicle is imported on a permanent basis. The amount subject to payment of import duties and taxes depends on engine capacity and year of production the car.</li> <li>▪ Non-residents of the Russian Federation can import their vehicles on a temporary basis for a period of 1 year. After this period, there is compulsory export outside the Customs</li> </ul>	<ul style="list-style-type: none"> <li>▪ Sometimes customs requires the presence of the owner of the vehicle during customs clearance.</li> <li>▪ Templates of required documents will be provided by the agent in Russia.</li> <li>▪ Vehicles, imported with the payment of the duties must comply with environmental class EURO5 and to be equipped with GLONASS system. <p><b>Works of Art</b></p>	<ul style="list-style-type: none"> <li>▪ For all items older than 100 years, certificate from the Ministry of Culture has to be obtained.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Modern items of art (not older than 100 years), except paintings made with oil paint on canvas, can be imported without certificate from the Ministry of Culture.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Works of arts include paintings, icons, musical instruments, collections, books older than 100 years.</li> <li>▪ All items of arts can be export out of Russia only after obtaining export certificate from the Ministry of Culture. In some cases, owner of the goods must be physically present at the airport customs terminal during customs clearance if there are any items of arts in the shipment.</li> </ul>
<p><b>Prohibited items</b></p>		<ul style="list-style-type: none"> <li>▪ Surface shipments: <ul style="list-style-type: none"> <li>▪ Food.</li> <li>▪ Alcohol.</li> <li>▪ Tobacco.</li> <li>▪ Medicines.</li> <li>▪ Flora and fauna objects *</li> <li>▪ Precious metals and stones.</li> <li>▪ Samples of minerals.</li> <li>▪ Objects of archaeological and paleontological excavation money in cash.</li> <li>▪ Debit or credit cards.</li> <li>▪ Passports.</li> <li>▪ Weapons, any items analogues to a weapon, ammunition, explosives.</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ Apply to all categories of persons transporting their goods.</li> <li>▪ * Import is possible in the presence of veterinary and phytosanitary certificates of the country of origin. 		<ul style="list-style-type: none"> <li>▪ Narcotic drugs, poisonous and intoxicant substances.</li> <li>▪ Radioactive substances, hazardous waste products.</li> <li>▪ Used tires</li> <li>▪ Printed matter/ cinematographic/photo/video materials, comprising confidential and/or state secrets, intended for propaganda of fascism, excitation of race, national and religious animosity, and the publications of pornographic character.</li> <li>▪ Airport security requirements for air shipment: <ul style="list-style-type: none"> <li>▪ PBO.</li> <li>▪ Toiletries and cosmetics containing spirits, liquids under the pressure (sprays, deodorants, aerosols, perfumes, nail polishes, wet tissues, creams, etc.).</li> <li>▪ Any food, tobacco (cigarettes), cartridges for printers, batteries (AA batteries), devices containing lithium-ion batteries (laptops, smartphones, cell phones, tablets, electronic books, etc.; as well as lithium-ion batteries itself, without device), medicines, mercury barometers or thermometers, explosive and pyrotechnic items, candles, flora and fauna objects, dry ice, flammable, infectious or poisoning items, radioactive substances, chemicals, reagents, test-probes, hazardous, household chemicals (wash powder, fabric softener, sanitizers, glue, dishwashing detergent, etc.), flammable, infectious or poisoning items, radioactive substances, chemicals, reagents.</li> </ul> </li> </ul>
